**INTENSIVE PROBATION**

**LEVEL ONE**

**RULES AND REGULATIONS**

1. Probationer must comply with all Orders of the Court, as well as Rules/Regulations of the Intensive Probation Program.
2. Must obey all laws of the State of Indiana and all terms and conditions of Intensive Probation.
3. Probationer must comply with curfew hours as established.
4. No carrying or possession of any weapons.
5. No avoidable contact with illegal drug or alcohol users.
6. No use, possession or contact with illegal drugs or alcohol.
7. Failure to check in with your Intensive Probation Officer is a violation.
8. Comply with all home rules and show respect for your parents/guardians.
9. No associating with other youth on Intensive Probation.
10. No avoidable contact with anyone known to be on probation or parole.
11. Game rooms and arcades are off limits.
12. May not attend social functions.

13. May not have any type of social media sites on home computer, i.e., twitter, facebook, etc. (Must close out account and provide proof to Probation Officer within \_\_\_\_\_ days.
14. Comply with all school behavior/attendance rules.
15. Probationer must report any change in their education/employment status to their Probation Officer immediately.
16. Parent/legal guardian must obtain prior permission from the Intensive personnel for the child to be away from home during established curfew hours.
17. Probationer and family are required to complete the treatment program established by the Intensive Probation Officers.
18. Level One child may be approved for one "call out" of no more than four consecutive hours for the weekend which starts on Friday at 4:00 p.m. and ends Sunday at 6:00 p.m. No "call out" will be approved for after Sunday at 6:00 p.m. "Call outs" for the weekend must be made by calling the Probation office prior to 3:00 p.m. on Thursdays to get approval.
19. Parent or legal guardian must accompany child on approved "call outs."
20. You will be allowed to have only two friends at your home at any time and the friends must be approved by the Intensive staff.
21. If the probationer is required to wear an anklet:
  - a. Probationer or other family members must not tamper with the equipment for any reason.
  - b. Probationer or other family members must not attempt to disconnect the equipment.
  - c. Probationer must contact their Intensive Probation Officer immediately if they experience problems with the equipment.
